Treasurer Report:

- Report was presented that showed a balance of \$20,085.64

- Carol detected a fraudulent charge on the HOA checking account debit card. She

 Ameris Bank and contested the charge. The charge was still on this month's statement

Architectural Control Committee Report:

- 2829 Royal Bluff roofing, window and storm door replacement projects approved.
- Neighbor reported an unkempt backyard at a home with a previous similar issue. The yard was taken care of on the day of the meeting without any HOA intervention.

Landscaping report:

- Fence replacement has been pushed to 2026 due to rising lumber costs.
- The county removed the broken curb at the front of the neighborhood and placed a form for a new concert pour. Hopefully that will happen in the next week or so.

Welcome Committee Report:

Old Business:

- The Bylaw review is nearly complete and Richard will have a final report at the next meeting if not before. Carol noted a discrepancy regarding late fees in the existing Covenants that Richard will have addressed.
- Brent Henderson expressed interest in replacing Matt as Vice President at the end of his term in October.
- Richard obtained a new "Neighborhood Watch" sign for the neighborhood. He also shared information about "Connect Dekalb County" that allows private citizens to register their personal surveillance cameras with the Dekalb County Police. Level 1 only lets the police know a camera is located at a particular address so they can ask for video in the event of a nearby crime. Level 2 allows them to access a live stream of the video via a purchased device. More info available at connectdekalbcounty.org.

New Business:

- It was suggested by several attendees that a portion of the HOA balance should be placed in a high yield savings account to help pay for the fence replacement. Carol and Richard will look into options and present them at the next meeting.
